WHAT IS A NEIGHBORHOOD WATCH GROUP?

Neighborhood Watch Groups are community-based crime prevention programs that encourage residents to work together and collaborate with local law enforcement agencies. These groups are driven by the idea that when neighbors actively look out for each other, crime rates can be effectively reduced.

WORKING TOGETHER AS A TEAM

- Law enforcement and citizens working together as a team is essential for a safer and more secure society.
 - Collaborative efforts between law enforcement agencies and community members can serve as a powerful deterrent to crime and contribute to the overall well-being of the community.
- By fostering positive relationships, encouraging open communication, and promoting mutual trust and respect, both parties can effectively address crime, enhance public safety, and build stronger, more resilient communities.

Benefits of Neighborhood Watch Groups

- Crime deterrence: The presence of active Neighborhood Watch Groups alone can act as a deterrent for criminal activities in our neighborhoods. Criminals are less likely to target a well-connected community that actively watches out for suspicious behavior.

 - Contact the Bethel Police Department: express your interest in starting a Neighborhood Watch Group. We will guide you through the process and provide necessary support.
 - Organize an initial meeting: Set a date, time, and location for an introductory meeting. Spread the word about the meeting to all members of your neighborhood

How to Start a Neighborhood Watch Group:

- Set goals and guidelines: During the meeting, establish the group's goals, responsibilities, and guidelines for communication and reporting.
- Develop a communication network: Utilize various communication channels, such as email lists, social media groups, or messaging apps, to establish effective communication among group members.
- Education and training: Arrange training sessions and educational programs in collaboration with the Bethel Police Department to ensure members are equipped with the essential knowledge and skills for crime prevention.
